DESCRIPTION OF CATEGORIES OF MEMBERSHIP

1. Permanent Membership (P)

- (a) Granted to applicants as per seniority on the waiting list.
- (b) Eligible to attend and vote at the AGM.
- (c) Green Card Membership granted to eligible wards.
- (d) Priority I for Accommodation.

2. Honorary Membership (H)

- (a) Earlier granted to distinguished persons (discontinued since 2014).
- (b) Granted to only the Patron of the Club
- (c) Annual Subscription exempted, but will pay other charges.
- (c) Not eligible to vote and attend the AGM, except the Patron.
- (e) Priority II for Accommodation.

3. <u>Senior Citizens (Hony Membership) (S)</u>

- (a) Granted to Permanent Members who are above the age of 70 years.
- (b) Not eligible to vote but can attend the AGM.
- (c) Annual Subscription exempted, but will pay other charges.
- (d) Green Card Membership granted to eligible wards.
- (e) Priority I for Accommodation.

4. Spouse Membership (L)

- (a) Granted to Only Widow/Widowers of Permanent / Life members.
- (b) Not eligible to vote and attend the AGM.
- (c) Green Card Membership granted to eligible wards.
- (d) Priority I for Accommodation.

5. Green Card Membership (G)

- (a) Granted to Children of Permanent, Life and Green Card members within the age of 21-28 Years.
- (b) Not eligible to vote and attend the AGM.
- (c) Priority II for Accommodation.

6. <u>Tenure Membership (U)</u>

- (a) Granted to all serving officers of Armed forces as long as posted at Kasauli, Dagshai, Solan, Sabathu and Jutogh.
- (b) Only serving officers of Armed forces are eligible to attend and vote at the AGM.

7. <u>Life Membership (M)</u>

- (a) Granted to applicants as per seniority on the waiting list.
- (b) Not eligible to vote and attend the AGM.
- (c) Green Card Membership granted to eligible wards.
- (d) Priority II for Accommodation.

8. Temporary Membership (T)

- (a) Granted to applicants as per seniority on the waiting list.
- (b) Not eligible to vote and attend the AGM.
- (c) Priority II for Accommodation

9. Corporate Membership (C).

- (a) Granted to Private and Public Ltd Companies listed in BSE or NIFTY having annual turnover of minimum of Rs 50 crore & having a standing of 5 years
- (b) Not eligible to vote and attend the AGM.
- (c) Priority II for Accommodation.
- (d) Tenure of membership is for 10 Years.

10. NRI Membership (N)

- (a) Granted to NRI's having Indian citizenship of those having PIO cards issued by the Indian embassies abroad.
- (b) Not eligible to vote and attend the AGM.
- (c) Priority II for Accommodation.
- (d) Tenure of membership is for 10 Years.

11. Annual Resident Membership (R).

- (a) Granted to applicants who are registered on the Permanent Membership waiting and owning residential property in Kasauli Tehsil.
- (b) Not eligible to vote and attend the AGM.
- (c) Will not be allotted residential accommodation.
- (e) Tenure of membership is one year.
- (d) Candidate to apply for renewal of ARM before Aug every year.
